1. Introduction

This annual summary bulletin brings together crime statistics from the Metropolitan Police Service (MPS) and British Transport Police (BTP) to provide a summary of recorded crime relating to TfL's public transport networks during Financial Year (FY) 2015/16 (1 April 2015-31 March 2016). This annual bulletin focuses on the London Bus network, London Underground (LU) / Docklands Light Railway (DLR)¹, London Tramlink and London Overground (LO) service.

The figures reported in this bulletin for the bus network are based on official MPS figures for bus-related crime unless otherwise stated. There is no distinct category of 'bus crime' in the MPS crime recording system. Recorded crime data is extracted from the MPS system using a complex query that searches all MPS crime for transport venue codes and those that have the word bus, bus stop, bus station and transport related words somewhere in the electronic case file. For this reason, some crimes that did not occur on the bus network will be included in the figures. This is different from the BTP as all crimes dealt with by the BTP and included on their crime recording system relate directly to the rail network.

Recorded crime figures relate to crime recorded by the MPS and BTP during FY 2015/16 and are consistent with Home Office counting rules. The figures do not include crimes that have not been reported to the police or those that the police decide not to record as crimes.

Public transport in London continues to be a safe and low crime environment. Currently, over ten million passengers travel on the TfL's public transport services each day with very few of them ever experiencing or witnessing crime.

While levels of transport crime remain low, figures from the MPS and BTP show that crime on the network has increased by 6.6 per cent in 2015/16 compared with 2014/15 which saw the lowest level of crime on record and nine consecutive years of crime reduction. The increases were anticipated and were largely driven by changes in the reporting and recording of certain offences – namely violence against the person (VAP) and sexual offences – reflecting wider increases seen across London and the UK generally, as well as the proactive efforts of TfL and the police to improve confidence in reporting of sexual offences. TfL and its police partners are redoubling their efforts and have put measures in place to deal with increases in crime on the network.

The headline figures include:

- The levels of pan-modal transport crime² in 2015/16 were 6.6% higher (1,845 more offences) than in 2014/15 and the rate of crime has increased to 7.4 crimes per million passenger journeys (from 7.0 in 2014/15), as can be seen in chart 1 and table 1.
- Levels of bus-related crime in 2015/16 were 1.5% higher (258 more offences) than in 2014/15 and the rate of crime for the bus network has risen to 7.5 crimes per million passenger journeys (from 7.2 in 2014/15).
- Crime on LU/DLR increased during 2015/16 by 11.7% (1,120 more offences) than in 2014/15 with the rate of crime rising to 7.3 crimes per million passenger journeys (from 6.8 in 2014/15).

¹ Crime figures for LU and DLR are reported together as these networks are policed by the same division of the BTP. 2 The pan-modal transport crime figure and rate is based on the aggregate crime and passenger journey figures for the bus, LU/DLR, Tramlink and LO networks.

- Crime on London Overground (LO) increased during 2015/16 by 56.4% (452 more offences) compared with the previous year. The rate of crime increased to 6.8 from 5.7 in 2014/15.
- Crime on London Tramlink increased by 6.0% during 2015/16 (15 more offences) compared with 2014/15 with the rate of crime rising to 9.6 crimes per million passenger journeys (from 8.1 in 2014/15).

The increase in the number of recorded sexual offences seen on the transport system was anticipated and is considered a positive result of Project Guardian, an initiative to reduce unwanted sexual behaviour on London's public transport which has historically been underreported. Project Guardian which includes the 'Report it to Stop it' communications campaign which was launched last year, aims to increase confidence in reporting sexual offences on the Capital's public transport, reduce the risk of becoming a victim, challenge unwanted sexual behaviour and target offenders. This important work continues.

The increase in VAP offences on the transport network reflects a wider increase in VAP being seen across London and other UK forces. The increase in low level VAP has is in large part been driven by a change in the way VAP offences are recorded by the police due to changes to recording practices. Serious violence remains very rare on the network.

From 31st May 2015, the former West Anglia suburban rail routes from Liverpool Street to northeast London became part of the LO network and offences relating to this part of the network are now reflected in the LO crime figures. This has resulted in an increase in the volume of crime and rate of crime for LO. It won't be possible to directly compare against previous figures until Q2 2016/17.

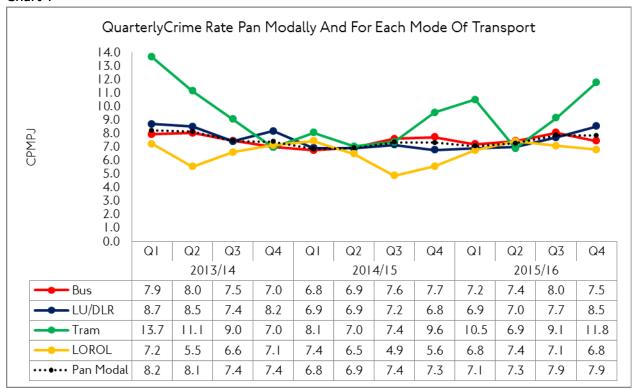

2. Bus-related Crime 2013/14-2015/16

Table 2 shows the break-down of MPS bus-related³ crime by the major crime categories used by the MPS for 2013/14, 2014/15 and 2015/16. It includes the rate of crime⁴ for each of these categories with the exception of burglary⁵. In 2015/16, there were 7.5 crimes for every million passenger journeys made on the bus network. Borough bus-related crime figures are shown in table 3.

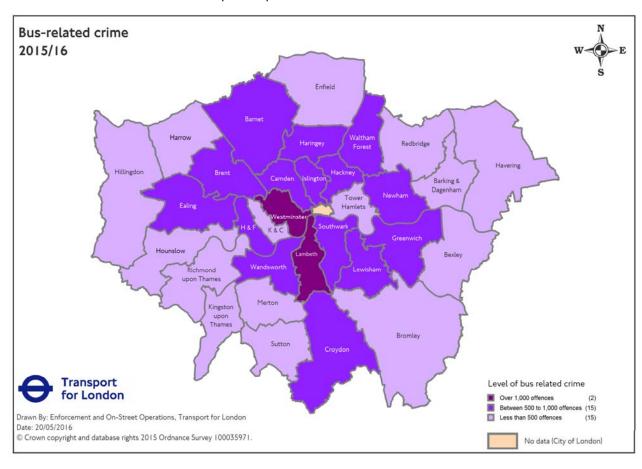
⁴ Rate of crime per million passenger journeys is calculated by dividing the number of crimes by the number of passenger journeys multiplied by one million.

⁶ Most burglaries take place in buildings and therefore it is not appropriate to calculate crime rates for burglary based on the number of passenger journeys made on the bus network.

^{*} Bus-related crime rates for, 2013/14, 2014/15 and 2015/16 are based on annual passenger journey figures of 2.405b, 2.385b and 2.314b respectively.

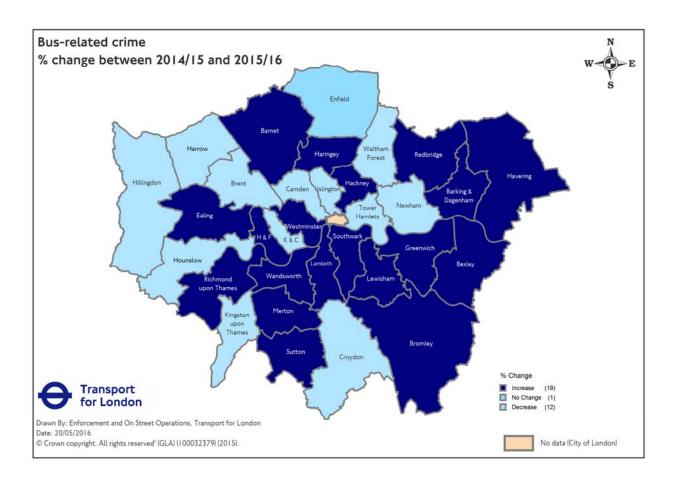
Map 1 – Bus-related crime volume by borough

Map I shows the breakdown of MPS bus-related crime by borough for 2015/16. The darker shades of purple show the boroughs with the highest number of recorded bus-related crimes. The map has not been adjusted for passenger or population numbers. Borough bus-related crime figures are shown in Table 3. Please note that the map below does not include data for the City of London; this is policed by the City of London Police (CoLP) which is a separate police force from the MPS.



Map 2 – Bus-related crime change between 2014/15 and 2015/16 by borough

Map 2 shows the percentage change in the levels of bus-related crime by borough⁶ between 2014/15 and 2015/16. The lighter blue boroughs have seen reductions in crime. The boroughs shaded in the darkest blue have seen an increase in levels of crime. Borough bus-related crime figures are shown in Table 3.



⁶ It is not possible to create similar maps of BTP recorded crime. The exact location of crimes upon the rail network is unknown due to some victims identifying the offence at the end of their journey which was undertaken across more than one borough.

3. London Underground and Docklands Light Railway Crime 2013/14–2015/16

Table 4 provides a breakdown of the major crime categories 7 used by the BTP for the LU and DLR networks in 2013/14, 2014/15 8 and 2015/16. There were 7.3 crimes for every million passenger journeys made on the LU and DLR networks in 2015/16.

4. London Overground Crime 2013/14 – 2015/16

Table 5 provides a breakdown of the major crime categories used by the BTP for the LO network in 2013/14, $2014/15^9$ and 2015/16. There were 5.7 crimes for every million passenger journeys made on the LO network in 2015/16.

5. London Tramlink Crime 2013/14 - 2015/16

Table 6 provides a breakdown of the major crime categories used by the BTP for the London Tramlink network in $2013/14\ 2014/15$ and $2015/16^{11}$. There were 9.6 crimes for every million passenger journeys made on the London Tramlink network in 2015/16.
