

# GREATER LONDON AUTHORITY ACT 1999 TRANSPORT ACT 2000

## Greater London Low Emission Zone Charging (Variation) (No. 2) Order 2018

Made

29 June 2018

Coming into force In accordance with articles 1(2) and 2(2) and (3)

Whereas—

- (1) the Greater London Low Emission Zone Charging Order 2006 (“the LEZ Scheme Order”) imposes charges for the use of specified classes of motor vehicles on designated roads within a specified area of Greater London;
- (2) it appears to Transport for London expedient, for the purposes of facilitating the achievement of policies and proposals in the Mayor of London’s Transport Strategy published pursuant to section 142 of the Greater London Authority Act 1999<sup>(a)</sup> that it should make an Order for the purposes of varying the LEZ Scheme Order:

Now, therefore, Transport for London, in exercise of the powers conferred on it by sections 295 and 420(1) of the Greater London Authority Act 1999, by Schedule 23 to that Act, and of all other powers enabling it in that behalf, hereby makes the following Order:—

### Citation and commencement

1.—(1) This Order may be cited as the Greater London Low Emission Zone Charging (Variation) (No. 2) Order 2018.

(2) This Order shall come into force on the day following the day on which the Mayor confirms it.

(3) In this Order “the LEZ Scheme” means the Scheme contained in the Schedule to the LEZ Scheme Order as varied and in force immediately before the coming into force of this Order.

### Variation of the LEZ Scheme

2.—(1) The Scheme set out in the Schedule to this Order (the “Variation Scheme”), which varies the LEZ Scheme shall have effect.

(2) The Variation Scheme shall come into force on such date, not being earlier than 8 April 2019, as may be appointed by the Mayor in accordance with paragraph (3).

(3) The Mayor shall cause to be published in the London Gazette notice of the appointment of a date under paragraph (2) and the general effect of the Variation Scheme coming into effect on that date, and the date so appointed shall not be earlier than the expiration of one month from the publication of the said notice.

- (3) In the table in Part 3A in the row corresponding with Sheet 18, after “OSIC/WEZ2010/18” insert “Rev 1” and for “David Brown” substitute “Gareth Powell”.
