Coming into force

In accordance with Article 1

Transport for London, in exercise of the powers conferred on it by sections 4 and 9 of the Metropolitan Public Carriage Act 1869(1), section 1 of the London Cab and Stage Carriage Act 1907(2) and sections 1 and 2 of the London Cab Act 1968(3) and of all other powers enabling it in that behalf hereby makes the following Order:—

1 Citation and commencement

- (1) This Order may be cited as the London Cab Order 2019.
- (2) Article 3 of this Order comes into force on 11 January 2020.

2 Preliminary

The London Cab Order 1934(4) (“the Principal Order”) is amended in accordance with the following provisions of this Order.

3 Fares for motor cabs

- (1) Article 40 of the Principal Order shall be substituted as follows:-
- (2) At 2(a)(i) for “116.6” substitute “113.5” and for “9561.2” substitute “9647.5”. At 2(a)(ii) for “25.1” substitute “24.4” and for “9561.2” substitute “9647.5”.
