Bus & Tram Discount scheme - Terms and Conditions

- These Terms and Conditions apply to applicants of the Transport for London ('TfL') Bus & Tram Discount scheme ('the scheme')
- The Bus & Tram Discount is not a statutory right. Any breach of the Terms and Conditions may result, at the discretion of TfL, in the withdrawal of your Bus & Tram Discount photocard and any associated Oyster cards. You may not be able to get another Bus & Tram Discount photocard
- The Bus & Tram Discount photocard is provided to you free of charge by TfL
- TfL reserves the right to refuse to issue a Bus & Tram Discount photocard
- · TfL reserves the right to terminate or revise the scheme at any time
- · The application form and photograph cannot be returned to you
- To qualify for the Bus & Tram Discount Scheme you must live in a London borough. If you don't, and you have been issued with a Bus & Tram Discount photocard in error, TfL may stop your Oyster card with the Bus & Tram Discount travel discount without notice
- You must be in receipt of the appropriate, qualifying benefit when you apply for a Bus & Tram Discount photocard. Once issued, you can continue to use the photocard and associated Oyster card to travel at discount rate until the photocard expires, even if you stop claiming the benefit
- To get discounted travel, you must carry both your valid Bus & Tram Discount photocard and your Oyster card with the Bus & Tram discount set on it on each journey. Just showing the Bus & Tram Discount photocard will not give you discounted travel
- All photocards and tickets are the property of TfL and are issued in accordance with TfL's Conditions of Carriage. Visit tfl.gov.uk/terms
- Your Bus & Tram Discount photocard shows your name and photograph. It and your Oyster card set with the Bus & Tram travel discount are for your use only. You cannot lend it to anyone else
- If you allow anyone else to use your Bus & Tram Discount photocard and any associated Oyster card, then your Oyster card may be stopped and your Bus & Tram Discount photocard withdrawn. The person found using it may be liable to a penalty fare and/or prosecution
- The Bus & Tram Discount photocard remains the property of TfL. TfL Staff or a Police Officer may withdraw any photocard or Oyster card
- The expiry date of your photocard is printed on the front of the card and it must not be used after this
 date. If you attempt to use the photocard after its expiry date, you may be liable to a penalty fare and/
 or prosecution
- The photocard is not valid if it is altered or defaced in any way. If it is, you must apply for a new Bus & Tram Discount photocard. You must then update the discount on your Oyster card before you can get discounted travel
- You must not apply for or be in possession of more than one valid Bus & Tram Discount photocard or more than one valid Oyster card with the Bus & Tram Discount set on it. TfL may stop additional Oyster cards with the Bus & Tram Discount without notice
- Your photocard should only be valid for six months. If your photocard has been issued for longer, TfL may stop your Oyster card set with the Bus & Tram Discount without notice
- TfL monitors the Bus & Tram Discount scheme to detect and prevent fraud. If there is any breach of these Terms and Conditions or TfL's Conditions of Carriage, TfL reserves the right to stop your associated Oyster card set with the Bus & Tram Discount without notice
- TfL reserves the right to amend these Terms and Conditions at any time. The most up to date version
