## Foreword

This document details all interior and exterior notices that are to be applied to DLR trains (1992 and 2007 stock). Locations for the notices are also provided.

Approved artwork for each notice shown is available from the TfL Graphics team (<u>corporatedesign@tfl.gov.uk</u>). No other artwork is to be used.

## I Basic elements

This section outlines the basic elements that are used to produce graphic notices for the DLR fleet. This includes the use of the corporate typeface and colours.

## 1.1 Typography

Our typeface is Johnston, which should be set in mixed upper and lower case.

New Johnston (NJ Font) Medium is the only typeface that should be used for train notices unless it is specifically stated otherwise.



- KI Priority area wheelchairs DLRTV\_INT\_019 Vertically - centred on window. Horizontally - top of notice 500mm from bottom of window.

#### K2 Priority area - pushchairs DLRTV\_INT\_019

This notice is to be used where the wheelchair bay has been converted to a multi-purpose area (2007 rolling stock only).

Vertically - centred on window. Horizontally - top of notice 500mm from bottom of window. L CCTV cameras/body-worn cameras/ in an emergency DLRTV\_INT\_045

#### On panel with alarm

Vertically - centred on panel. Horizontally - 10mm above alarm recess.

#### On panel without alarm

Vertically - centred on panel. Horizontally - top of notice is aligned with version on panel with alarm.

# C Obstructing doors/shark teeth (left)

DLRTV\_EXT\_047A Vertically - against opening edge of inner panel of left opening car doors. Horizontally - centred between top of door window and door opening button.

# D Obstructing doors/shark teeth (right)

DLRTV\_EXT\_047B Vertically - against opening edge of inner panel of right opening car doors.

Horizontally - top of notice aligned with top of notice on left-sided door.

### E Wheelchair entry

DLRTV\_EXT\_008 Vertically - 10mm from window edge. Horizontally - bottom of notice 50mm from bottom of door window.

### F Door open

DLRTV\_INT\_0II Placed over door open button.

### G Risk of death

DLRTV\_EXT\_040 Vertically - centred on panel. Horizontally - top of notice in line with top of windows.


### H Car reference numbers

DLRTV\_INT\_009 Vertically - centred between window and car end. Horizontally - top of notice in line with top of windows.

### J DLR web address
