London Freight Enforcement Partnership Newsletter (June 2017)

The London Freight Enforcement Partnership brings together the City of London Police (CoLP), the Driver and Vehicle Standards Agency (DVSA), the Metropolitan Police Service (MPS) and Transport for London (TfL) to target dangerously non-compliant drivers, vehicles and operators on London's roads.

This newsletter is published on a quarterly basis to highlight the work undertaken by the Partnership and key stakeholders to rid London's roads of unsafe HGVs.

Highlights

Roadside activity

The London Freight Enforcement Partnership continues to undertake high-visibility and undercover roadside activity in London. To date the Partnership has stopped over 24,000 vehicles and reported over 6,500 offences. Roadside officers have also issued over 4,300 prohibitions to the most dangerous vehicles on London's roads.

Example of good partnership activity

In March the director of DBS Scaffolding Ltd who had a licence revoked by the Traffic Commission in April 2016 was caught applying for a new licence. The director, who had also failed to apply for a new licence in November 2016, was attempting to set up a new company called DB8 Scaffold Ltd.

ANPR was used to track the movements of the vehicles that were previously registered to DBS Scaffolding Ltd and were found to still being used on the roads. The vehicles were found on roads close to the proposed new operating centre of DB8 Scaffold Ltd.

This information was provided to the police who the next day stopped a fully laden vehicle leaving the operating centre. The DVSA were called and the vehicle was impounded.

This is one of many examples of multi-agency work leading to a positive outcome.
