London Freight Enforcement Partnership Newsletter (November 2017)

The London Freight Enforcement Partnership brings together the City of London Police (CoLP), the Driver and Vehicle Standards Agency (DVSA), the Metropolitan Police Service (MPS) and Transport for London (TfL) to target dangerously non-compliant drivers, vehicles and operators on London's roads.

This newsletter is published on a quarterly basis to highlight the work undertaken by the Partnership and key stakeholders to rid London's roads of unsafe HGVs.

Highlights

Roadside activity

The London Freight Enforcement Partnership continues to undertake high-visibility and undercover roadside activity in London. To date the Partnership has stopped over 33,000 vehicles and reported over 9,000 offences. Roadside officers have also issued over 5,600 prohibitions to the most dangerous vehicles on London's roads.

Excellent Operator Engagement

The Freight Compliance Unit identified a problem with a well known wholesale supplier, who were attracting fines for offences with the loading of their goods. An officer from the City of London Police identified the source of the problem by liaising with the drivers, which was new loading and strapping equipment the company had been issued.

She arranged a visit at the company's headquarters which she attended with a Health & Safety Executive from transport load security. It was initially thought that the problem may have been a local training issue at a specific Operating Centre in London, but it is actually a nationwide problem involving all 330 of their vehicles, across 13 operating centres. The company were pleased to have the involvement and help of the Partnership. A plan was put in place for them to re-train their drivers and warehouse loaders and to buy and supply the new straps with a long term objective to find a system that reduces the effort and risk of misuse and error by the driver.

When the training package is complete they are going to disseminate it to the Partnership to spread across the Police and DVSA and inform people of the systems they have taken on board.

The Health & Safety Executive will take this case to the Logistics Forum on 1 November. This is a forum jointly branded with the DVSA where the largest of transport companies, unions, manufacturers and enforcement agencies together discuss new legislation and









changes in the industry. She will use the case as a standard to be expected and how they came to reach this level with our interaction and advice.

This is an excellent example of how operator engagement can solve an issue and influence progress within the industry.
