# London Freight Enforcement Partnership Newsletter (December 2016)

The London Freight Enforcement Partnership brings together the City of London Police (CoLP), the Driver and Vehicle Standards Agency (DVSA), the Metropolitan Police Service (MPS) and Transport for London (TfL) to target dangerously non-compliant drivers, vehicles and operators on London's roads.

This is the first edition of the London Freight Enforcement Partnership Newsletter. This will be published on a quarterly basis to highlight the work undertaken by the Partnership and key stakeholders to rid London's roads of unsafe HGVs.

### Success to Date

Launched on 1 October 2015, the London Freight Enforcement Partnership has now been operating for over a year. During that time over 18,900 vehicles have been stopped and checked with over 3,402 roadside prohibitions and 5,004 Fixed Penalty Notices being issued to the most non-compliant vehicles.

Since launch, the Partnership has continued to refer the most dangerous operators to the Office of the Traffic Commissioner, resulting in the most non-compliant operators having their licences revoked, suspended or curtailed. The Partnership also continues to prosecute the most dangerous drivers and operators with £62,595 of fines being issued at court since the 1 October as a result of Partnership activity.

Following the implementation of the Freight Compliance Unit (FCU), the Partnership is now supported by the UK's first and only jointly staffed intelligence unit dedicated to freight enforcement. Made up of staff from TfL, DVSA and the MPS, and with direct links to the CoLP, the FCU ensures information is shared between agencies allowing the most dangerous operators to be identified, targeted, prosecuted and referred to the Traffic Commissioner.

The Partnership has worked to implement a formal governance structure and a system of joint tasking which ensures that operational resources are effectively co-ordinated and targeted at those vehicles which pose the most risk to other road users.

The Partnership has also continued to engage with industry and other stakeholder groups and has set up forums at which these discussions can take place.

London now has the most intensive commercial vehicle enforcement of any area of the UK which ensures that those drivers and operators who choose to flout their obligations and choose to put other road users in danger will be stopped, checked and prosecuted to the full extent of the law.









Steve Burton, Director of Enforcement and On-Street Operations at TfL, has praised the Partnership: "The joint working demonstrated by the London Freight Enforcement Partnership is a fantastic example of how we can achieve more by working together. The Partnership is an essential part of our ongoing effort to ensure that London's roads are free from dangerous and non-compliant drivers, vehicles and operators."

## **Highlights**

#### **Good court result**

On 17 June 2016, officers from the Industrial HGV Task Force (a joint unit comprised of officers from the Metropolitan Police Service, the City of London Police and the Driver and Vehicle Standards Agency) stopped a vehicle belonging to Knight Scaffolding Ltd. The vehicle was found being used illegally and in a dangerous condition, as well as having no MOT.

Following the roadside stop the case was passed to City of London Magistrates Court who heard the case on 19 August and issued the operator with fines totalling £4,000 plus costs. The offences for which the operator was found guilty include using a vehicle in a dangerous condition, exceeding the number of vehicles on an operator licence, failure to display an operators licence, no goods vehicle test certificate and having no ministry plate fitted.

The operator was subsequently referred to the Traffic Commissioner for London and the South East. Following a public inquiry on 29 September the operator's licence was revoked.

#### **Public inquiry result**

Following targeted roadside activity as a result of a FCU tasking, the Industrial HGV Task Force visited the operating centre of Deadman Confidential, a confidential waste disposal and shredding business.

This visit resulted in the examiners identifying numerous failings. These failings were documented and the operator was referred to the Office of the Traffic Commissioner. Following a Public Inquiry the Traffic Commissioner made the decision to revoke the operators licence effective from 8 October 2016.

#### Joint Investigation

The below article was previously published in Commercial Motor on 11 July 2016.

These operators came to light following roadside enforcement activity instigated by the joint investigative work of the FCU.

The two owners of a recycling business have each been banned from holding an O-licence for five years after being given numerous chances to run a compliant operation.

The Traffic Commissioner (TC) for London and the South East also revoked the O-licence held by a Brentford based partnership between Jamie and Kellie Adamberry, which traded as Talking Rubbish. The partnership operated in excess of its two vehicle authorisation by adding trucks on to other operators' O-licences. It also failed to provide tachograph data to the TC and lacked financial standing.









Jamie Adamberry received several convictions for driving an overweight vehicle – one of which was 24% overweight – and driving without the correct entitlement for a 7.5-tonne vehicle and Driver CPC. The operator did not inform the TC of the convictions.

Jamie Adamberry had been involved in a string of failed transport businesses before Talking Rubbish. He was a director at A&A Recycling, which went into liquidation in 2012, and his sole trader business had its O-licence curtailed in 2014 after he consistently failed to analyse drivers' hours records. He later surrendered the sole trader O-licence.

He was also involved in another partnership that traded as Talking Rubbish, but its Olicence was revoked in September 2014 after the TC found it had failed to ensure that drivers' hours rules were followed and had not kept vehicles fit and serviceable.

A Public Inquiry, which the operator did not attend, was told that a Talking Rubbish liveried HGV was found to be displaying an O-licence disc issued to another operator, Brentford Commercials, in October last year. Jamie Adamberry told a DVSA examiner that he had added the vehicle onto Brentford Commercials' O-licence as it knew it did not have permission to operate three vehicles.

Brentford Commercials also had its O-licence revoked following the PI and its director and transport manager Matthew Walsh was disqualified for three years.

A vehicle was stopped again last month displaying an O-licence disc issued to West Kensington-based Future Green Fuels Holdings, and the driver told the DVSA he took instructions from Jamie Adamberry.

The TC concluded that the business was continuing to operate under the guise of Future Green Fuels Holdings. In his written decision last month, the TC said Jamie Adamberry's promises of future compliance given at a PI in 2014 "turned out to be worthless."

"He has been given many chances to run a compliant operation, instead of which he has consistently failed to make any meaningful improvement at all, and in many respects has got worse," the TC said. He added that while Kellie Adamberry had not been as directly culpable as Jamie Adamberry, she had failed to exercise her responsibilities as an operator. "She has been exceptionally negligent in her management of the operator's licence," he said. Denton said he could find "nothing positive to put in the balance" when coming to his decision.
