This form is intended to support individuals requesting access to images of themselves captured by CCTV cameras on the London Overground (LO) network. Please note: CCTV footage from LO stations are normally retained for a maximum of **31 days**. If the footage requested was onboard a train, please note that footage is only retained for **14 days**.

To enable us to respond to your request promptly, please ensure you provide us with:

- The relevant date, location and approximate time
- A description of what is happening in the footage
- A detailed description of what you were wearing/carrying at the time;
- A recent full-length colour photograph of you
