## Transport for London <br> Lost Property Office transparency data

Transport for London (TfL) is responsible for the collection, safekeeping, restoration and disposal of items of property found on TfL services and premises.

We operate within the bounds of the London Transport Act I982 and the London Cab Order 1934. These articles specify the period of time we hold property, our right to charge and collect fees, the information we require from customers before releasing goods, and the transfer of ownership for unclaimed items.

Data schedule
We publish annual data for the previous three financial years showing:
A. the number of items found and reclaimed, by item category and TfL service;
B. the number of items received and reclaimed from the LPO, by item sub-category; and
C. a summary of revenue received.

This document covers the period of April 2019 to March 2022. Data is compiled three months after the end of the reporting period, accounting for the timeframe in which items that have been found may still be reclaimed by owners.
