These are subject to external audit by Janet Dawson, Partner, Ernst & Young LLP. Members of the public and local government electors have certain rights in the audit process.

From 2 June to 13 July 2023, between 9.30am and 4.30pm on weekdays, any person interested may inspect the accounting records of Transport for London for the year ended 31 March 2023 and all books, deeds, contracts, bills, vouchers, receipts and other documents relating to those records, and may make copies of all or any part of those records or documents except as provided for in Section 26(4) to 26(6) of the Local Audit and Accountability Act 2014 in relation to commercially confidential and personal information.

The accounts and other documents will be available for inspection at Palestra by prior arrangement. Please email <a href="mailto:Patrick.Doig@tfl.gov.uk">Patrick.Doig@tfl.gov.uk</a> to make arrangements to inspect the accounts and documents. The accounts will also be available on TfL's website: <a href="https://tfl.gov.uk/corporate/publications-and-reports/annual-report">https://tfl.gov.uk/corporate/publications-and-reports/annual-report</a>.

During this period, a local government elector for any area to which the accounts relate, or their representative, may question the auditor about the accounts, or make an objection to the accounts as set out in sections 26 and 27 of the Local Audit and Accountability Act 2014. Any objection, and the grounds on which it is made, must be sent to the auditor in writing, with a copy to the Statutory Chief Finance Officer at the address given below. Any objection must state the grounds on which the objection is being made and particulars of:

- i. Any item of account which is alleged to be contrary to law under section 28 of the Local Audit and Accountability Act 2014; and
- ii. Any matter in respect of which it is proposed that the auditor could make a public interest report under section 24 of, and paragraph 1 of Schedule 7 to, the Local Audit and Accountability Act 2014.
