Coming into force

In accordance with Article 1

Transport for London, in exercise of the powers conferred on it by sections 4. 8 and 9 of the Metropolitan Public Carriage Act 1869(1), section 1 of the London Cab and Stage Carriage Act 1907(2) and section 1 of the London Cab Act 1968(3) and of all other powers enabling it in that behalf, hereby makes the following Order:—

### 1 Citation and commencement

- (1) This Order may be cited as the London Cab Order 2016.
- (2) Article 3 of this Order comes into force on 2 April 2016.
- (3) Article 4 of this Order comes into force on 3 October 2016.

# 2 Preliminary

The London Cab Order 1934(4) ("the Principal Order") is amended in accordance with the following provisions of this Order.

### 3 Fares for motor cabs

- (1) Article 40 of the Principal Order is amended as follows.
- (2) Paragraph 40(2) is omitted and the following paragraph is substituted:
  - "(2) Exclusive of sums payable by virtue of sub-paragraph (4), the rates are—
  - (a) for any part of the journey which takes place between the hours of 5 am and 8 pm, on any day except a Saturday, Sunday or public holiday,
  - (i) during which the cab travels at a speed exceeding 4.65 metres per second, the rate of 20p for 123.9 metres or the rate of 20p for 86.9 metres for distance travelled in excess of 9656.1 metres;

- (ii) during which the cab is stationary or travels at a speed not exceeding 4.65 metres per second, the rate of 20p for 26.6 seconds or the rate of 20p for 18.7 seconds for distance travelled in excess of 9656.1 metres;
- (b) for any part of the journey that takes place on a Saturday or Sunday (other than a public holiday) between the hours of 5 am and 8 pm, or on any day (other than a public holiday) between the hours of 8 pm and 10 pm,
- (i) during which the cab travels at a speed exceeding 4.65 metres per second, the rate of 20p for 100.6 metres or the rate of 20p for 86.9 metres for distance travelled in excess of 9656.1 metres;
- (ii) during which the cab is stationary or travels at a speed not exceeding 4.65 metres per second, the rate of 20p for 21.6 seconds or the rate of 20p for 18.7 seconds for distance travelled in excess of 9656.1 metres;
- (c) for any part of the journey that takes place between 10 pm on any day and 5 am on the following day or at any time on a public holiday--
- (i) during which the cab travels at a speed exceeding 4.65 metres per second, the rate of 20p for 81.2 metres or the rate of 20p for 86.9 metres for distance travelled in excess of 9656.1 metres;
- (ii) during which the cab is stationary or travels at a speed not exceeding 4.65 metres per second, the rate of 20p for 17.5 seconds or the rate of 20p for 18.7 seconds for distance travelled in excess of 9656.1metres."
- (3) In paragraph 40(3) for "£2.40" wherever it occurs substitute "£2.60".
- (4) Sub-paragraph 40(4)(e) is omitted.

# 4 Debit and Credit Card Acceptance

(1) The following is added after article 31 of the Principal Order -

## "31A Debit and Credit Card Acceptance

(1) Every cab-driver's licence shall be granted subject to a condition that, if so requested by a passenger, the licensee shall accept payment by credit or debit card using a payment device approved by Transport for London."
